# 2019 ELIGIBILITY GUIDELINES

Every year, we recognize exceptional, pioneering work in the fight to overcome Crohn's and ulcerative colitis, with three prizes – two **\$100,000** Sherman Prizes for excellent achievement and one **\$25,000** Sherman Emerging Leader Prize for a person who has shown high potential. The Sherman Prize is open to individuals who have demonstrated excellence in areas such as those listed below.

## Patient Care

Healthcare professionals who provide outstanding and responsive clinical care, and make strides to improve the physical, emotional and/or psychosocial aspects of treatment:

- Identifying risk factors for Crohn's and colitis and improving diagnosis.
- Improving patients' quality of care and their social and emotional well-being.
- Supporting emerging clinicians to make a significant impact in the field.
- Providing patients with the opportunity to make informed decisions about their care and treatment, as well as comprehensive and culturally appropriate communications tailored to the patient's needs.
- Providing families and caregivers with information and support.
- Providing outstanding care demonstrating mastery of the clinical management of compassionate and effective treatment of IBD patients.

## Medical Research

Medical and research professionals who perform groundbreaking scientific research in pursuit of treatment advances or cures:

- Studying risk factors for Crohn's and colitis in an effort to improve diagnosis.
- Determining the environmental and/or genetic factors that enhance the risk of Crohn's and colitis.
- Deepening our understanding of the multiple disease processes under the umbrella of Crohn's and colitis.
- Developing tools that will predict the aggressiveness of the disease, whether complications will develop, and how individual patients will respond to particular therapies.
- Studying new medications and treatments that induce remission and prevent relapse.
- Discovering ways to prevent complications.
- Encouraging multidisciplinary research focused on new technologies and systems to treat and cure Crohn's and colitis.
- Predicting and preventing the onset of these diseases in high-risk individuals.

## Public Service & Education

Healthcare providers, educators and advocates who go above and beyond in support of awareness, education, and patient and public advocacy:

- Enhancing quality of life for people with Crohn's and colitis through support groups or peer-to-peer assistance.
- Leading advocacy efforts to enhance public policies on behalf of those with Crohn's and colitis.
- Training and inspiring the next generation of gastroenterology specialists through excellent teaching.
- Leading communication and education efforts to:
  - Inform the public of the risk factors for the diseases.
  - Raise awareness on the environmental and genetic factors that enhance the risk or progression of the diseases.
  - Effectively educate patients and professionals about IBD.
  - Mentor and support trainees and junior faculty to develop meaningful careers in IBD.
  - Raise awareness of new medications and treatments that induce remission and prevent relapse of the diseases.

The deadline for submitting 2019 Nominations is **February 8, 2019**. Eligible individuals must live and work in the U.S., having accomplished their greatest achievements in the past decade, with greater emphasis placed on accomplishments in the last few years.
